REGULAR SESSION

I. CALL TO ORDER AND PLEDGE OF ALLEGIANCE:

V. CONSENT CALENDAR: Minutes for Regular Meeting on March 17, 2025, stand approved with corrections.

VI. REPORTS

- **1. Sheriff's Office:** This month in Canyonville, the Sheriff's Office received 184 calls for service, 30 reports taken, 42 traffic stops, 17 citations written, 17 arrests, 2 warrant arrests, 3 drug cases, and 1 car accident.

The Public Hearing closed at 7:35 p.m.

Councilor O'Sullivan moved, and Councilor Morgan seconded a motion to determine the buildings located at 430 S. Main St. as dangerous buildings and to be removed. Mayor Morgan, Councilors Briggs, Freeman, Morgan, O'Sullivan, and Suhr voted "yes." No "nays." The motion carried.

Time frame for removal:

Councilor O'Sullivan moved, and Councilor Suhr seconded a motion to set a time frame of 120 days to complete the removal of the dangerous building located at 430 N. Main St. Mayor Morgan, Councilors Briggs, Freeman, Morgan, O'Sullivan, and Suhr voted "yes." No "nays." The motion carried.

Resolution No. 718: Councilor O'Sullivan moved, and Councilor Morgan seconded a motion to set a public hearing for May 19, 2025, at 7 p.m., at the City of Canyonville Council Chamber at City Hall for the existence of a dangerous building on the property of 164 Wright Street Canyonville, Oregon, parcel R36814. Mayor Morgan, Councilors Briggs, Freeman, Morgan, O'Sullivan, and Suhr voted "yes." No "nays." The motion carried.
- 2. Resolution No. 719: Councilor O'Sullivan moved, and Councilor Freeman seconded a motion to approve Resolution No. 719 authorizing a transfer of appropriations within the General Fund in the Administration section, Public Officials section, Municipal Court section, and the Auxiliary section. Mayor Morgan, Councilors Briggs, Freeman, Morgan, O'Sullivan, and Suhr voted "yes." No "nays." The motion carried.
- 3. Declare Vacant Council Seat: Councilor O'Sullivan moved, and Councilor Briggs seconded a motion to declare a Council seat vacancy and authorize staff to post the vacancy with no deadline, until there is a qualified applicant. Mayor Morgan, Councilors Briggs, Freeman, Morgan, O'Sullivan, and Suhr voted "yes." No "nays." The motion carried.
- 4. Administrator Bennett went over City Financials for the 2023-2024 Audit.
